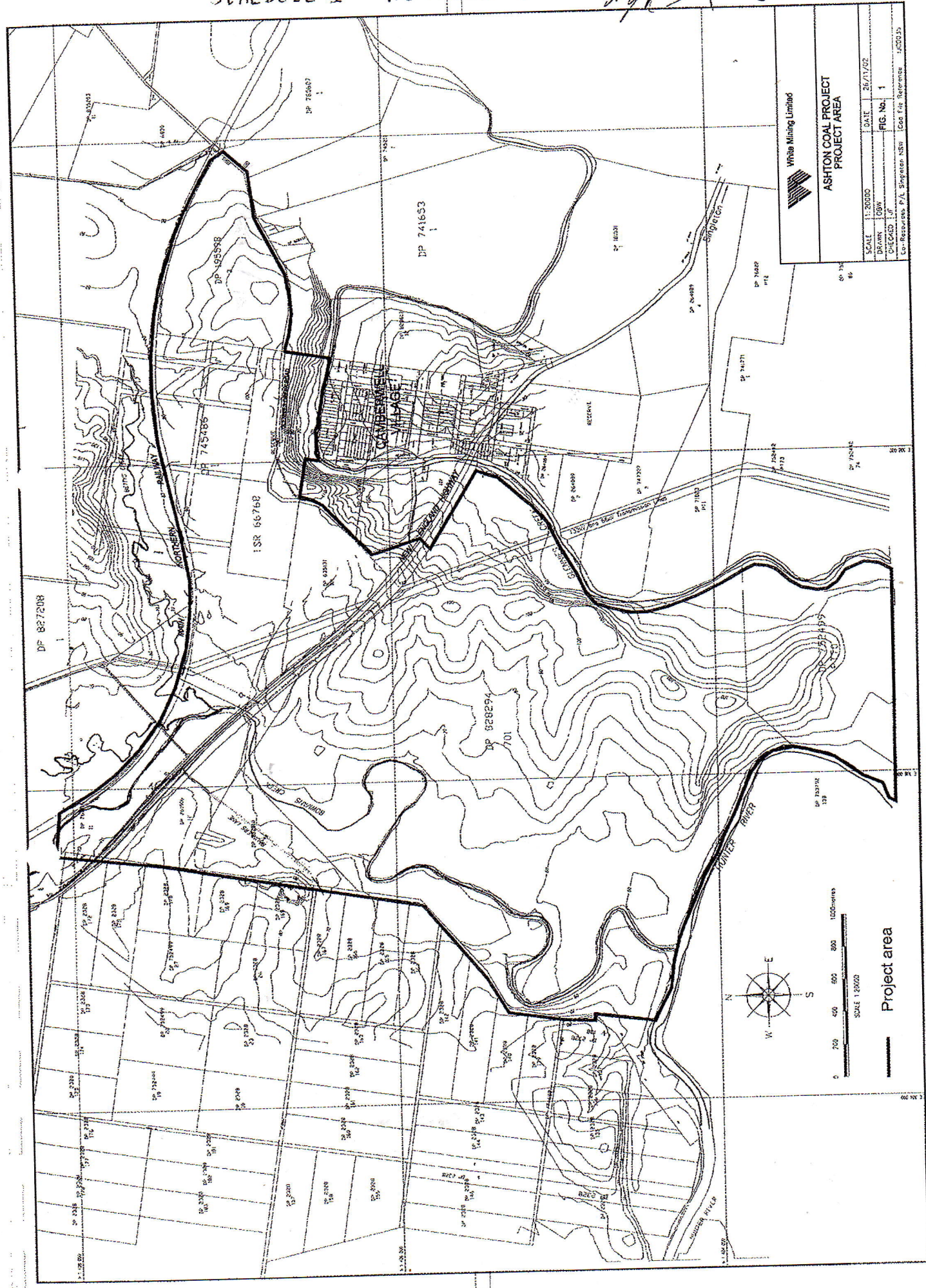
RECITALS

- A. WML has applied for mining lease applications 190 ("MLA 190") and 201 and has requested that they be issued to WML, WM(NSW) and ICRA Ashton (together referred to as the "Tenement Holders").
- B. New South Wales has given notice of its intention to grant MLA 190 pursuant to section 29 of the NTA.
- C. ACOL is a joint venture company owned by WM (NSW) and ICRA Ashton and will conduct the Mining Operations as operator for and on behalf of the Tenement Holders .
- D. Tom Miller on behalf of the Wonnarua People has lodged an application for a determination of native title (Federal Court No NG 6008 of 2002) in respect of part of the Project Area. The application has been entered in the Register of Native Title Claims maintained by the National Native Title Tribunal pursuant to the NTA.
- E. The Wonnarua People maintain that in accordance with Aboriginal tradition and custom they have a continuing connection with the Hunter Valley of New South Wales, which includes the Project Area and such continuing connection includes native title rights and interests.

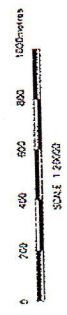
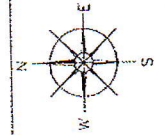
SCHEDULE 1 - THE PROJECT AREA
